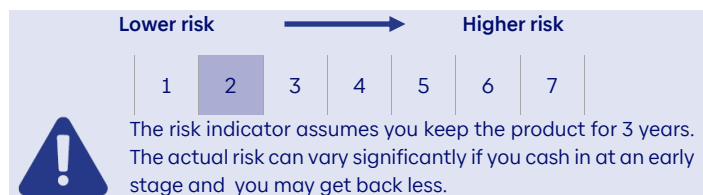
Objectives

The objective of this investment strategy is to enhance the value of short-term capital by favouring a conservative distribution of investments between the various asset classes. The portfolio will be fully invested in fixed income or money market assets. Investments will be made on the European and international markets. The recommended investment horizon is a minimum of 3 years.

Intended Retail investor

The conservative profile for a targeted investment strategy is intended for investors wishing to employ a very low level of risk taking. The investment strategy of the proposed targeted investment strategy must be consistent with the risk appetite profile of the investor, the analysis of their needs and objectives as well as their experience regarding the investments defined above. The "conservative" strategy is intended for subscribers who prefer short-term investments.

What are the risks and what could I get in return?



Risk Indicator:

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified the risk of this investment option at 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level and, poor market conditions are very unlikely to impact the capacity to pay you.

Cost over the time
