What is the product?

Objectives

The objective of this investment strategy is to enhance the value of short-term capital by favouring a defensive distribution of investments between the various asset classes. The portfolio will be fully invested in equity, bond, money market or diversified assets. Investments will be made on the European and international markets. The recommended investment horizon is a minimum of 3 years.

Intended Retail investor
