# What is the product?

Objectives

The objective of this investment strategy is to enhance long-term capital appreciation by favouring a dynamic distribution of investments between the various asset classes. The portfolio will be invested entirely in equity, bond, money market or diversified assets with an investment in equities ranging from 0% to 100%. Investments will be made on the European and international markets. The recommended investment horizon is a minimum of 5 years.
